
With our history spanning decades, Morganti has established itself as a nationwide leader across various sectors.


When Morganti was founded in 1916, our focus began in the residential market, which continued as the company grew. Starting in the 1960s, Morganti expanded its expertise into Wastewater Treatment/Infrstructure, Healthcare, and K-12 Education construction, setting the stage for a diverse project portfolio. In the 1970s, the company ventured into private development, focusing on Retail, Office, and Mixed-Use projects. By 1993, Morganti broadened its impact by partnering with the federal government, marking the start of significant government and military collaborations.

The early 2000s ushered in an era of growth in K-12 Education and Government and Municipal projects, particularly in Connecticut, Florida, Texas, and Massachusetts. More recently, Morganti entered the Entertainment and Recreation sector in 2018, further diversifying its project base.

Today, Morganti's historical portfolio reflects its adaptability and breadth, with a strong emphasis on Aviation and Transportation (21%) and K-12 Education (27%), alongside significant contributions to Higher Education (17%), Government and Municipal projects (9%), and Healthcare (5%).

Smaller yet impactful sectors include Entertainment and Recreation (2%), Federal and Military (2%), and Utility and Infrastructure (4%). This broad expertise underscores Morganti's ability to deliver exceptional results across a wide range of industries.






